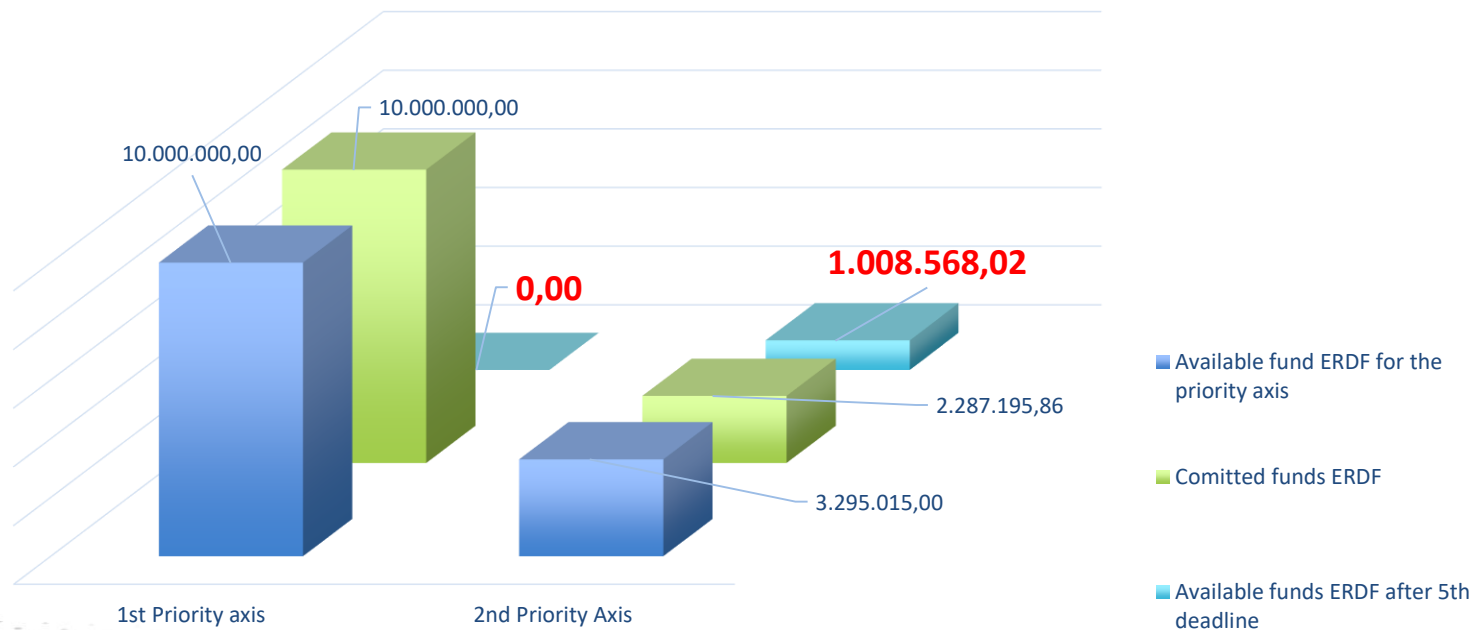


Committed ERDF funds till now





AVAILABLE FUNDS ERDF



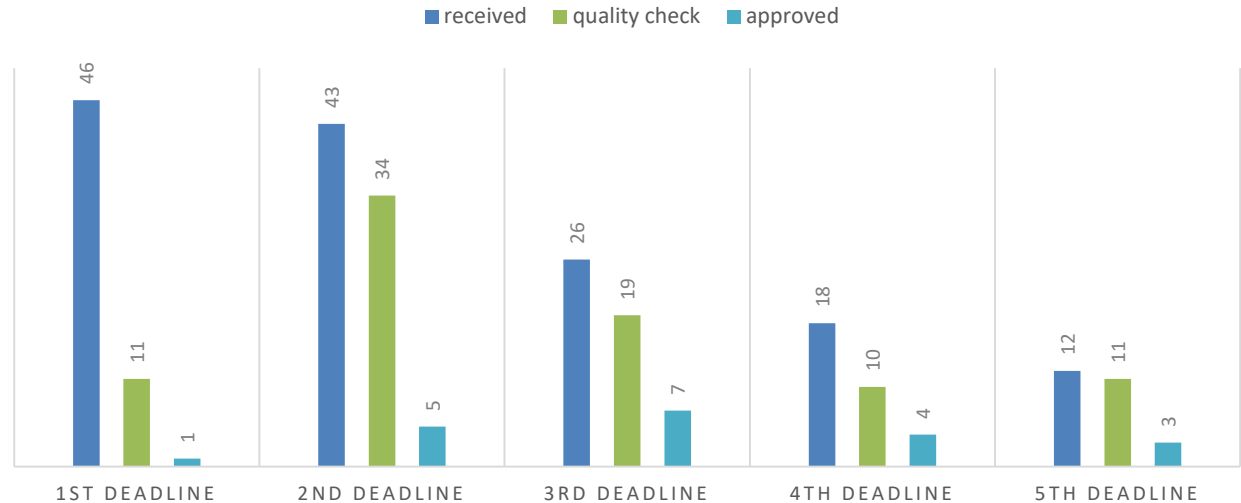

BASIC CALL DATA

- ✓ **CALL DOCUMENTATION** – Call, Implementation Manula for beneficiaries, Annexes
- ✓ **PARTNERSHIP** - at least one PP from SLO and one from HU or EGTC
- ✓ **PROJECT SIZE:** Priority Axis 1: at least 50.000 EUR ERDF funds
- ✓ not more than 2.000.000 EUR ERDF
Priority Axis 2: at least 20.000 EUR ERDF funds
not more than 350.000 EUR ERDF
- ✓ **DURATION** – up to 36 months
- ✓ **ERDF** to max. 85% of the total costs; at least 15% is to be ensured from other sources.
- ✓ **PREPARATION OF THE PROJECT** – orientation towards the results – PROJECT INTERVENTION LOGIC
- ✓ **SUBMISSION OF APPLICATION** - the application can only be submitted by a Lead partner, solely via eMS
- ✓ The application must be bilingual (Slovene and Hungarian), except for the summary it must be in SI, HU and EN

- *6. Thematic objective, 6c Investment Priority: „Conserving, protecting, promoting and developing natural and cultural heritage“*
- Programme specific objective:
 - To increase the attractiveness of the programme area
 - Crossborder diversification and cross-border integration and diversification of the sustainable touristic offer
 - Protection of the elements of cultural and natural heritage
 - The development of products and services in the less developed rural areas linking them to touristic magnets



2nd Priority Axis – COOPERATIVE REGION

Thematic Objective 11 - Investment priority 11b

Enhancing institutional capacity of public authorities and stakeholders and efficient public administration by promoting legal and administrative cooperation and cooperation between citizens and institutions



2nd Priority Axis

Specific objective

To increase the capacity for cooperation in order to reach a higher level of maturity in cross-border relations

- by strengthening and deepening relations (new stakeholders, broader areas of cooperation);
- by improving institutional capacity;
- by improving public services and exploiting cross-border contacts.



Philosophy of the program

- Catalyzing, strengthening cooperation → jointly solving common problems → exchange of experiences, permanent, stable institutional contacts → better community service



Projects in implementation

To raise the institutional capacity and cooperation:

- in the field of cultural heritage (open-air museums, folk music, cultural institutions)
- in the field of education
- in the field of environmental protection, energy efficiency, renewable energy
- in the field of local economy (ecosocial market economy, economy institutions, social enterprises,..)

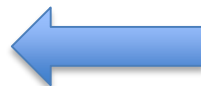
